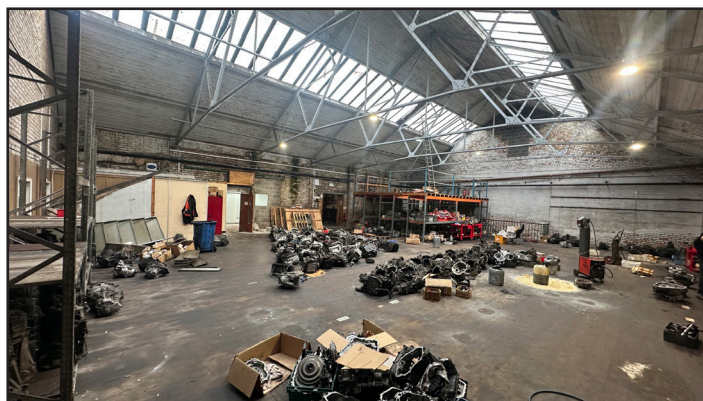

LOCATION

The property is prominently situated on Brasenose Road, close to its intersection with Bankhall Street, which leads to Derby Road (A565) and Stanley Road (A567), the two main arterial roads leading north from Liverpool City Centre through to Bootle, within close proximity to Liverpool Docks.

Liverpool City Centre is located approximately 2.4 miles to the south and the M62 motorway is located approximately 6 miles to the southeast. Bootle Town Centre is approximately half a mile to the north.

Bankhall Merseyrail Station is located a short walk away and the property is well placed for both public transport and rail communications about the area.

DESCRIPTION

Comprises a substantial industrial premises, providing warehouse accommodation. Access is via a roller shutter door from Brasenose Road which leads into the main warehouse. The roofs are pitched with plastic coated metal profile sheets and tile roof coverings.

The property opens to the rear providing further warehouse space with exposed steel beams and multiple skylights providing natural light. The space connects to a separate storage room with suspended ceiling and fluorescent lighting. There is an additional external door providing access to enclosed car parking to the side. WC facilities are also provided.

All main services are available and the property benefits from a three-phase power supply. The minimum clear height in the main warehouse is 15 feet (4.6 metres). The property would suit a variety of different uses, subject to a change of use if necessary.

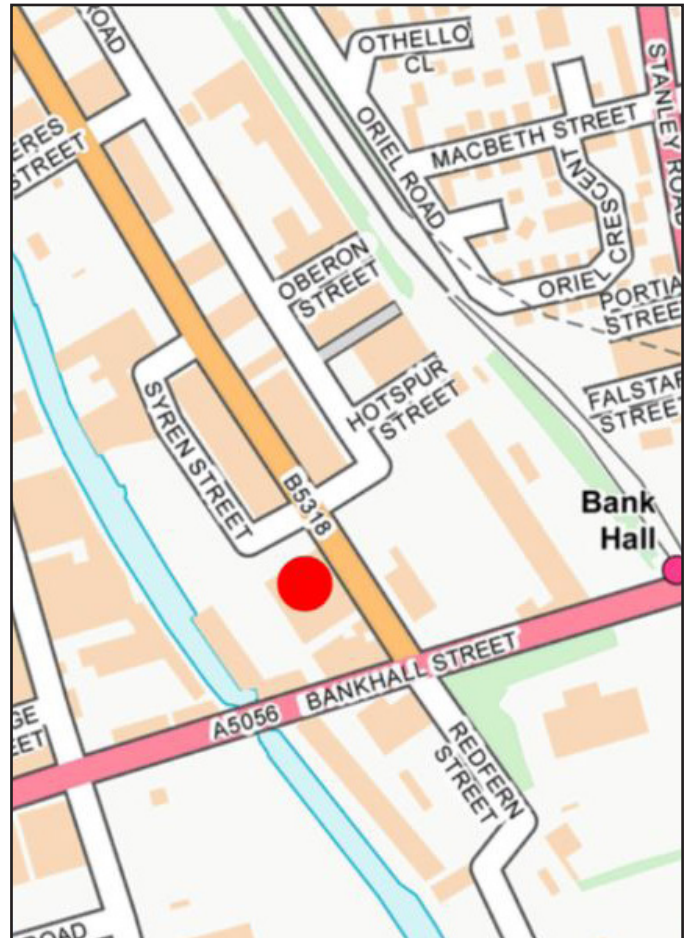
