SITUATION AND DESCRIPTION

Huyton is a popular town in the Knowsley Borough of Liverpool situated approximately 7 miles east of Liverpool City Centre with excellent access and communications to both the M57 and M62 Motorways serving the Huyton and Prescot surrounding population.

The property comprises of a two-storey retail property centrally positioned on Derby Road opposite Superdrug. The property has most recently been used as a banking hall on the ground floor with offices, staff and ancillary accommodation at first floor. 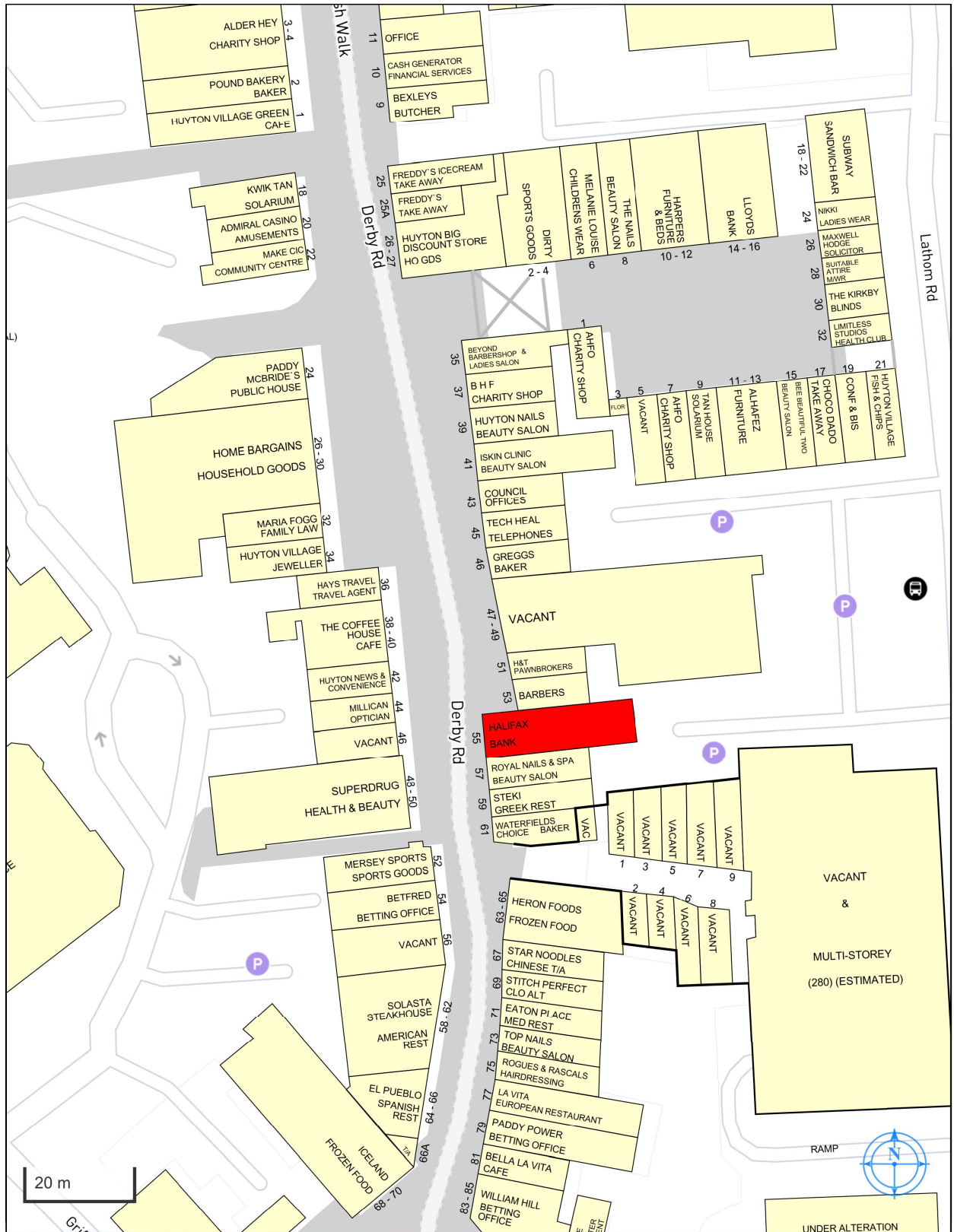
