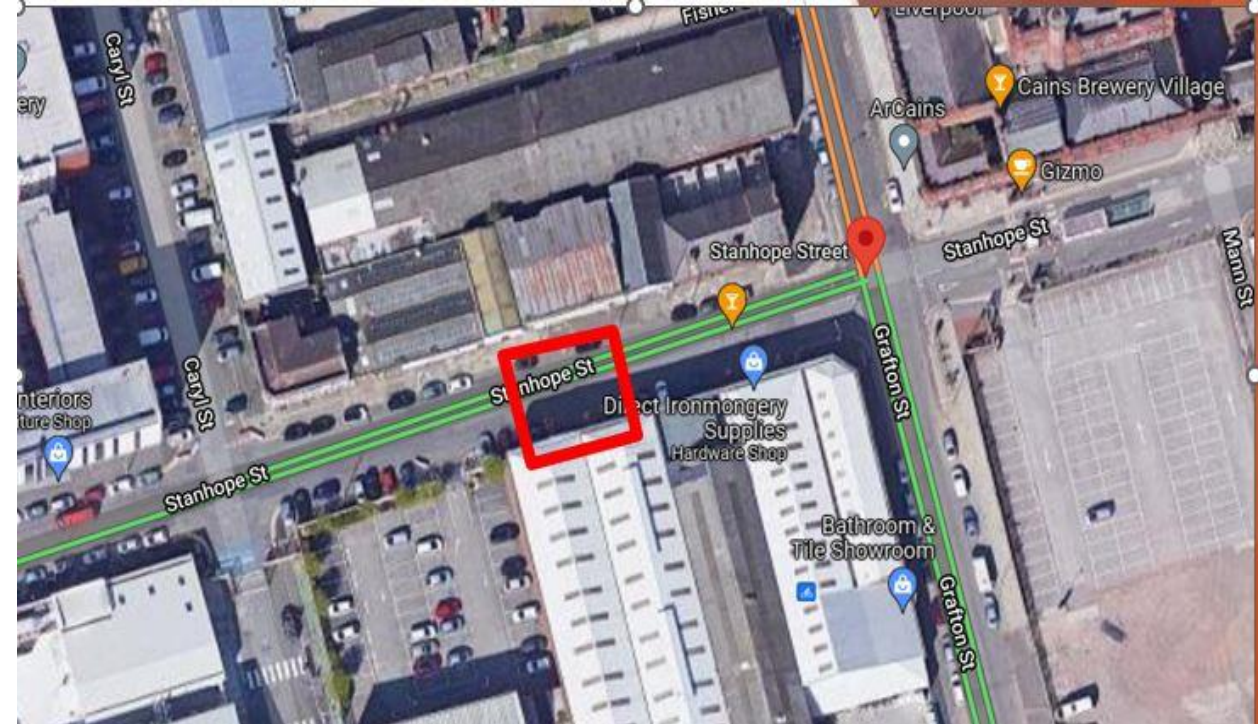

## LOCATION

The property is located within the Cains Brewery Village / Baltic Triangle area of Liverpool City Centre, in close proximity to the Liverpool Waterfront, the retail core of the city centre, Ropewalks and the Knowledge Quarter.

The area has undergone a radical regeneration over the past decade, driven by the Creative Industries sector, which has resulted in the eclectic mix of occupiers and uses evidenced as at today's date. Adjacent occupiers include H1780 Tap & Still Brewery, the Baltic Bakehouse and Eyre & Ellison, whilst within the wider vicinity Baltic Creative, Camp & Furnace, McDonalds and KFC are in occupation. Box park have also recently taken a substantial warehouse building that will be Liverpool's major cultural and creative hub. A fully integrated all day dining and events space. It will feature 8 independent traders from the city and include an external feature terrace for alfresco dining.

There are also a number of commercial, residential, student and hotel developments either under construction or constructed within the immediate vicinity of the subject site.







## DESCRIPTION

The property comprises a traditional 2 storey brick construction former warehouse facility set beneath a pitched trussed roof structure. The building has rendered brick elevations, a profile clad roof and a roller shutter loading door directly onto the Stanhope Street thoroughfare.

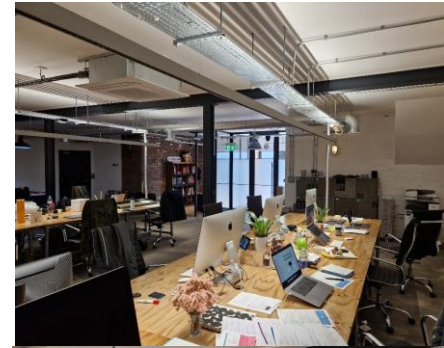
